1. Standard pricing (NT\$) for hiring one (1) bike of the following models

**Deposit** for booking: Valid Passport or ID per bike to be returned when the bike(s) and all its accessories are returned to the lessor in good condition.

- Insurance: **lessee or user of the bike is responsible for purchasing personal injury insurance.**
- Lessee or user of the bike should decide on the appropriate routes, travel time, rest stops, etc. according to their own physical condition, cycling skills, and experience on the road, so as to ensure personal safety. If there is anything abnormal about the bike, the user should stop using the bike immediately and notify the lessor as soon as possible.
- When using the bike, the lessee or user should comply with the regulations set out in the section about slow-moving vehicles in Article 3 of Road Traffic Management and Penalty Act, and those set out in the section about slow-moving vehicles in Article 5 of Road Traffic Safety Regulations.
- During the rental period, for any incidents caused by the lessee or user of the bike that incur penalty, the payment should be borne by the lessee or user.
- Lessee or user of the bike should be responsible for safekeeping the bike during the rental period. Actions like re-selling, pledging, and pawning the bike are forbidden.
- If there is any incident with the bike that causes injuries, death, or loss of property of the lessee, user, or a third party, unless the situation does not allow, the lessee or user of the bike should report to the police and notify the lessor immediately, and the lease should cease thereafter. If the lessee or user is responsible for the incident, the lessee or user should bear legal liability and be responsible for any compensation. If there is any damage to the bike caused by the lessee or user, the lessee or user should be responsible for compensation. **There will be an extra day charge if the bike is brought back in an unacceptable condition.**
- If the bike is lost during the rental period, unless the situation does not allow it, the lessee or user of the bike should report to the police and notify the lessor immediately, and the lease should cease thereafter. If the loss of the bike is caused by the lessee or user, the lessee or user should be responsible for compensation.
- Compensation amount for the aforementioned situation is as follows and not higher than the cost of the bike:  
 Trigon HC-01: NT\$100,000 per bike      Standard Road Bike: NT\$25,000 per bike  
 Merida Explorer: NT\$15,000 per bike

If the lessee fails to show up at the agreed time and location without notifying the lessor, an administrative cost of NT\$1,000 and respective overdue charges will be deducted from the deposit.

14. If the bike incurs any damage to the frame, the renter must compensate the amount to have it fixed. Heavy scratches more than 5cm will incur a NT\$4,000 charge on carbon bikes.

15. If the bike falls on its side, be aware the rear derailleur can be heavily damaged and will cause further damage unless fixed promptly.
